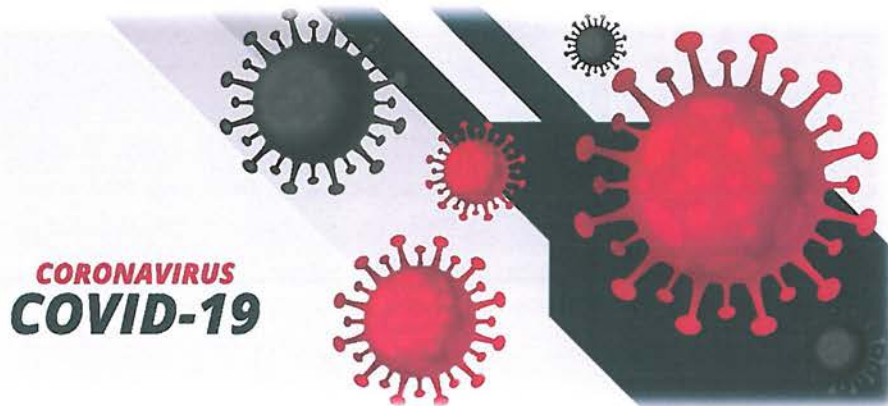

REOPENING TENNIS ACTIVITIES REQUEST

Reopening Procedure Steps

STEP 1: Read & Fill up the Return to Tennis Guidelines, Information Form, Sanitary Protocols & Commitment & Regulation & Procedures for the Return of Sport Activities in Sport Establishment / GOVERNMENT OF DUBAI.

STEP 2: Submit the Signed requested forms to the UAE TF within 3 working Days after receiving the document by e-mail or official website www.uaetennis.ae to the email: events@uaetennis.ae

STEP 3: Wait for the Reopening Permit from UAE TF (1-2 working days).

STEP 4: Submit the UAE TF Reopening Permit to Dubai Sports Council by the link:

www.dubaisc.ae/SportsPermitUnderCovid19

and wait for Final Approval.

STEP 5: Open your Tennis Institution according to the ITF Tennis Guidelines, Sanitary Protocols & Precaution measures, after receiving the Final Approval from DSC.

REGULATION & PROCEDURES FOR THE RETURN OF SPORT ACTIVITIES IN SPORT ESTABLISHMENT GOVERNMENT OF DUBAI

REGULATIONS AND PROCEDURES FOR THE RETURN OF SPORTS ACTIVITIES IN SPORTS ESTABLISHMENTS

In accordance with the regulations issued by the Supreme Committee of Crisis and Disaster Management, and the precautionary measures developed to protect those who practice sports from the COVID-19 pandemic; and upon consultation and co-ordination with the relevant authorities as part of the preparations for the return of sports activities and reopening sports facilities in Dubai, the following measures and guidelines shall be observed, as per the nature of the sports establishment's activities:

1. Sports facilities and all tools, equipment, and means of transportation shall be sanitized through a certificate issued by a sterilization company approved by the Dubai Municipality. A permanent sanitization program shall be put in place, and sanitizers shall be provided in the necessary areas in the establishment. **(ONLY FOR INDOOR VENUES)**
2. A physical distance of at least 2 meters must be maintained, and separators/partitions (e.g. acrylic dividers) shall be installed between sports equipment, if the nature of the sports activity requires it, to ensure protection of people.
3. Prepare for the return of the activity at a maximum of 50% of the facility's normal capacity. Each facility shall specify its working hours in line with the time available outside the National Sterilization Program times.
4. Close off waiting areas, and ensure lockers rooms, changing rooms, and shower booths (shower, Sauna, Jacuzzi) are closed off. Furthermore, trainers and instructors are not allowed to gather in any area.
5. Bathrooms/toilets must be sanitized after each use, or at least once every hour.
6. All athletes/visitors/members must wear a face mask at all time and while engaged in light or moderate physical activity, but can be lowered/removed while engaged in strenuous physical exercise.
7. Frequently used equipment that are used or touched by members must be cleaned. Floors and equipment must always be cleaned after each use.
8. Provide equipment to measure the temperature of customers, employees, trainers and participants before the start of every training session. Anyone with a temperature of over 37.5 degrees shall not be allowed in the facility.
9. Individuals below the age of 12 and above 60 are not allowed to practice activities.
10. A person who has a cough, temperature, breathing difficulty, respiratory disease or immunodeficiency, shall not be allowed to participate in the sports activities.

11. Guidelines and instructions issued by health authorities, and updated from time to time, shall be observed and strictly followed.
12. The return of activity does not include swimming and water sports centers that are practiced indoor, and the return of the activity in them will be determined later.
13. Instructions issued by the Supreme Committee of Crisis and Disaster Management in Dubai, the Department of Economic Development, Dubai Sports Council and relevant authorities, shall be observed and strictly followed.

ITF RETURN TO TENNIS GUIDELINES

Minimum and recommended standards

The tables below set out the minimum and recommended standards for the organisation of tennis competitions. These guidelines can only mitigate the risk of COVID-19 infections – they cannot eliminate it. Any return to competition and implementation of this guidance should be established in conjunction with the relevant national authorities.

MINIMUM STANDARDS	
Actions	Comments
Implement social distancing:	
Modify changeovers.	Players go around opposite sides of the net.
Keep on-court officials and players separate.	Separate players from the Chair Umpire and (doubles) each other.
Eliminate handshake and other forms of physical contact.	
Players use separate sets of balls.	Identify and mark different balls for each player.
Implement the ITF Towel policy.	Provide a container for all disposable items.
Players should arrive at the venue close to their allotted starting time and in playing kit and depart immediately after (no showers).	
No sharing of equipment;	Individual food and water bottles.
Play behind closed doors or with limited/separated spectators.	Put all spectators (where permitted) at least 2 metres apart.
Physical separation at locations where people tend to gather.	Mark separation distances for, e.g., food/drink and toilets.
Establish hygiene standards:	
Daily cleaning and disinfecting of all shared areas frequently.	
Ball kids wear latex gloves on court.	
Officials, staff and ball kids wear masks off-court.	
Provide hygiene notices for players, officials and spectators.	

RECOMMENDED STANDARDS

Actions	Comments
All minimum standards, plus:	
Play outdoors.	
Play singles only.	
Provide to players: tissues; plastic bags; masks; alcohol-based hand wipes; disposable drinking cups; thermometer; sanitiser.	
Provide access to an on-site/on-call doctor.	Isolation room; emergency contact person; evacuation procedure.
Conduct daily health checks of players, officials and staff.	Daily testing and self-certification of being symptom-free.
Maintain contact details of all staff, officials and players.	Trace contacts in case on-site infection found.
Devise a business continuity protocol (in case of infection).	Build redundancy into staffing, e.g. split officiating teams into 2.
Establish protocols if COVID-19 symptoms are developed on-site.

THE SANITARY PROTOCOLS & THE PRECAUTION MEASURES.

REQUIREMENT

A Tennis institution has to commit to provide and respect the following: -

1. Designate the COVID-19 Supervisor.
2. Cooperate with the UAE TF COVID-19 Committee inspection & provide weekly Report.
3. Nominate the authorized Coaches.
4. Provide the list of Authorized Players Members / Non-Members.
5. Proceed to Sensitization and maintain the Club.
6. Close the locker rooms & Club House.
7. Provide a special Forehead Thermometer & measure the players & staffs Temperature every session.
8. All the staff must wear Mask & Gloves.
9. Provide Sterilizers for all persons in the venue.
10. Announce the activity timing which must be in respect with "NATIONAL DISINFECTION PROGRAMME".
11. Keep a safe distance between the players, Coaches & Staff.
12. Follow the Precaution Measures by UAE – MOH.

UAE TENNIS FEDERATION

ON COURT PRECAUTION REQUIREMENT

1. Players must bring their equipment's & drinking waters.
2. use strips to give everyone their starting spot -2m or more away from each other
3. Everyone brings their own sanitizer and use before and after class starts
4. Give exercises that are at least maintaining 2 meters of distance & max 2 students on one side of the court
5. students from same family can stand next to each other if they like
6. Use strips/dots to assign everyone their spot for rest- and drinking moments
7. Balls will be fed by the Coach only
8. each pick up tube will be assigned to one student for the whole class and sterilized after each class, balls will not be touched during pick up
9. Everyone will bring his own set of balls signed with a mark for practising serve. During pick up you only pick up your marked balls.
10. if you are able to do pick up the balls without touching, pick up is allowed and starting the rally is ok.

Guidelines for Return to Tennis



Permission to open and reactivate tennis coaching by UAE TF and DSC



Over 12 & below 60 maximum **4** players + 1 coach per court



Only use your own equipment and **mark** your tennis balls



A supervisor will be present at this club

ENTRANCE

Drop off and pick up of juniors at club **entrance** only



Only arrive with an **appointment** (lesson or individual) preferably with a (digital) reservation



Arrive at **confirmed** time, but at most 10 minutes early



Coaches stay 2 Meter apart from their students



Only enter clubhouse for using the bathroom



The clubhouse and terrace are **closed**



Do **not** share a bench together



Change sides only clockwise



Sweeping of tennis courts only by coach and/or supervisor



After playing tennis immediately return home



Unfortunately under 12 & over 60 **not** welcome yet

Hygiene Rules

- All players & coaches Keep your distance to others at least 2 Meter
- Wash your hands thoroughly **before** and **after** playing tennis
- Do **not** shake hands or high five each other/**no** chest bumps either!
- Cough and sneeze in your elbow and use paper tissues
- Do **not** use the score cards
- Stay home when you have one or more of the following symptoms: cold, running nose, sore throat, light cough and/or a body temperature above 37°.78
- Stay home if someone in your household has a fever (37°.78 & above) and/or shortness of breath
